



### **Duties of the applicant**

- 1.- Affix the athorised wheelmark and, under the notified body responsability, their id number in every approved product described at EC type certificate according to the related and detailed international instruments.
  - 1.1.- The wheelmark must be placed on the product in a visible place, readable and indelible. When this could not be possible or it could not be guaranteed due to the product nature, it could be placed on the packaging and attached documents.
  - 1.2.- The Wheelmark must be placed on the production final stage.
- 1.3.- The wheelmark must be completed with the notified body id number and the year of mark affixment. 2.- Write a conformity declaration for each product type and keep them at disposal of National Authorities during a period of at least ten years since the mark affixment of the produced products and never less than the expected lifespan of the marine equipment. This declaration must contain the covered model identification. Copies of this declaration would be provided to the National Authorities that request them.
- 3.- State their name, their registered marketing id or trademark and their contact address (single info with clear access) at the product, or on the packaging and attached documents when impossible, or both.
- 4.- Manufacturer must ensure that the product include instructions and all the required information for the on board installation and use in a safe way, including the limitations of use, if relevant, being easily understandable by users, together to all the documentation required by the international instruments or test standards.
- 5.- Cooperate with the competent authorities to, under their request, in any action in order to reduce any risk related with the product introduced into the market.
